

Letter of Recommendation

It is with great honor that I nominate Lowell S. Berg, AIA, for the Harry F. Cunningham Gold Medal award.

For the last 43 years, I have known Lowell in several capacities starting as fellow students at the University of Nebraska College of Architecture and later as business partners in the firm of The Clark Enersen Partners. We are both at the close of our long careers but remain good friends. Over the past four decades, I have known Lowell to be a consummate professional dedicated to building a better world. Whereas Lowell has been a guiding influence in my own professional growth as an architect, I have also witnessed his influence on generations of other architects as they grew from student interns into highly talented professionals.

Lowell's impact on design stretches throughout Nebraska and nationally. As a designer— whether working in areas of education, commercial, office or residential design—Lowell has championed modernism as an aesthetic statement in order to meet the needs of clients and the people who occupy the spaces created for them. This dedication to modern design has had a positive and valued impact on the communities and people he has touched on every project. As a mentor to young architects, Lowell has impacted the direction of design for many other firms in Nebraska and the region as the young architects he has mentored have gone on with their successful careers. Mentoring is something Lowell championed by virtue of his high standards—critical-but-fair eyes rooted by in-depth knowledge of all aspects of design. Lowell is more than a mentor, though; he inspires achievement beyond one's own self-imposed limitations.

Lowell's impact on the communities he has served goes beyond just his relationships with design professionals. Over Lowell's successful career, he has worked to expand a client's definition of design beyond just meeting the functional needs of the project. It has been Lowell's philosophy that great design occurs from the meaningful intertwining of a project's aesthetic impact on the community while meeting the programmatic needs for its users. The result is thoughtful design that endures.

Finally, Lowell's dedication to serving a community goes beyond his commitment to achieving community-enhancing design. Lowell has dedicated his personal time to public, private, and philanthropic organizations within Nebraska and the nation. By pairing his philosophy of design with his organizational prowess, Lowell has been effective as a leader for our local Rotary Club #14 and Rotary International; First Plymouth Church, for whom he is a member and deacon; and the University of Nebraska College of Architecture—just to mention a few.

At the top of his list of professional commitments is Lowell's dedication to AIA Nebraska. His many years of service on AIA's Governmental Affairs Committee has provided strong leadership instrumental to our profession's interests. His dedication to providing awareness of the positive or negative impacts that proposed changes in state law would have for our profession and the public has protected the public and kept our profession strong.

For his entire career, Lowell has been able to bring leadership through an architectural prism of problem-solving for each organization he has represented, including AIA Nebraska. In closing, Lowell embodies the principles set forth by Harry F. Cunningham, making him a strong candidate to receive the Harry F. Cunningham Gold Medal award.

Biographical Data

Lowell Berg views an architect's education, expertise, and social awareness as components of a unique "tool-kit", which should be shared with others to assist in problem solving on a wide array of applications. Lowell has conducted his entire professional career as a leader with a broad vision of sharing his professional knowledge and expertise with other architects, other design professionals, and those who are seeking the services of an architect (and those who are not) because he believes in the value of architecture in society, communities, and individual lives.

Lowell began his professional career in 1975 at Clark & Enersen, Hamersky, Schalebitz, Burroughs and Thomsen. He began his tenure at the firm as a designer under the guidance of the firm's founders and Harvard graduates K.B. Clark and Larry Enersen (1995 Cunningham Medal winner). Lowell's talent and leadership abilities allowed him to rise to senior principal and board member and eventually president to succeed his mentor, MIT Graduate and 2010 Cunningham Medal Winner Albert Hamersky in 1989. Lowell's vision and leadership as president of The Clark Enersen Partners from 1989 to 2008, transformed the firm and positioned it for unprecedented growth and excellence in design. Lowell led the effort to re-establish engineering disciplines in the firm in 1993, after a 15-year absence of mechanical, electrical, and structural engineering services. This fulfilled his vision for the firm to provide a holistic approach to design. Lowell also led the effort to open additional offices in Nebraska, Missouri, and Kansas. Under Lowell's direction and mentorship, these initiatives also created design leadership opportunities for younger architects within the firm.

Lowell's immediate influence on designers and design excellence at The Clark Enersen Partners was primarily focused on libraries, corporate office buildings, and government buildings. I have known Lowell for over 20 years stemming from our participation in the American Institute of Architects, National Committee on Design. The leadership of that group includes a very high level of nationally respected professionals. It also requires the respect of colleagues with similar stature. Also, not all architects are willing to selflessly dedicate time and resources to furthering the education of others. Lowell not only led with distinction but generously offered himself to help others. In particular, when I was elected chairman in 2001, I reached out to Lowell to help organize an extended conference in Lincoln and Omaha for our group. He not only was able to reach out to key players in the community and arrange for "behind the scenes" visits to significant architectural buildings. He talked to issues and local architectural history in a way that emphasized civic pride and the importance of design as a symbol of community, or as your guidelines state, he showed us "evidence of a profound effect on the profession of architecture in Nebraska." That conference was only weeks after 9/11, and the spirit of democracy was at a peak. Lowell spoke beautifully to the over arching message that architecture can unite us.
