Professional Leadership

"Lead by Doing" is the driving force behind Kevin's commitment to professional advocacy early in his career. He currently serves as Associate Director on both the AIA Omaha Board of Directors as well as the AIA Nebraska Board of Directors. He also Chairs the AIA Nebraska Emerging Professionals Committee and is part of the AIA Central States Region Emerging Professionals Committee. Through these positions he has handled a number of projects, primarily focusing on professional development and advocacy for emerging professionals.

A major project that Kevin took charge of is the ARE Success Teams Program, a coordinated study program formed by the AIA Nebraska Emerging Professionals Committee to provide ARE candidates with the tools, mentorship, and resources necessary to pass all six divisions of the ARE within one year. As Chair of the AIA Nebraska Emerging Professionals Committee, Kevin was able to garner support for the program with planning beginning in 2021 and an official launch in January 2022. Kevin's role within the program includes general management, establishing study teams, writing and distributing study guides for all six exams, scheduling at least one educational seminar per series of exams (practice series & technical series), and recruiting members, in addition to leading a Success Team himself. The ARE Success Teams Program currently has twenty members between Omaha, Lincoln, and Central Nebraska with more being added regularly throughout the year. Through this endeavor a number of members have already started passing their first exams, highlighting the impact such a program can have on kick-starting the professional development of future architects.

Kevin's commitment to professional advocacy is also apparent in the initiative he takes to work with connections outside the sphere of architecture for the benefit of the profession. Through attending a series of local artist exhibitions, he established a connection with a local gallery coordinator who showed interest in partnering with AIA Nebraska to promote architectural discourse among the art community and general public. Kevin partnered with the gallery coordinator and another AIA Omaha Board Member to formulate a plan for an exhibition that will feature work from the Cunningham Bronze Medal Finalists who participated in the graduate thesis program at the University of Nebraska-Lincoln College of Architecture. Kevin's role is to work between the coordinator, students, and college faculty to plan the budget, secure gallery space, promote the event, and facilitate the transfer of student work from Lincoln to Omaha. By maintaining strong relationships with all parties involved, Kevin has received support from David Karle, Director of the Architecture program at UNL, to pursue the goal of making a graduate thesis exhibition an annual event. The benefits of this project are significant in that the exhibit brings together academia, practicing professionals, and the general public, all while enhancing relationships within the local community.

Mentorship

Kevin is regularly involved in a number of mentorship activities, including portfolio reviews & career fair prep at the University of Nebraska-Lincoln, but he is most active through mentoring in local high schools as part of the ACE Mentor Program of America. Through ACE, Kevin is able to engage with young people who may otherwise lack the resources necessary to learn about architecture as a career path. Once a week during the school year he meets with students in the classroom to help them work on a semester-long or year-long architecture project. As part of the ACE program he has also taken leadership within his firm to provide high schoolers with interning and job-shadowing opportunities through the ACE Mentorship & Experience program. As such, Kevin is in charge of planning a two week program within his office to provide a valuable learning experience for student mentees as they take the first steps in planning their career paths.

Advancing Design


Leaning on his experience as a finalist in the SGH/Dri-Design Competition and contributing to award winning submissions in previous internships, Kevin realized that even early in his career he could make an impact on professional practice. Beginning in his current role, Kevin made a point to rework the AIA Nebraska award submission process, placing extra emphasis on the value of drawing and diagramming. After working with his colleagues to develop a design culture around awards season, the office brought in an AIA Nebraska Merit Award for a project which had long been deserving of such recognition. In addition, Kevin has worked to establish a culture of knowledge sharing to advance design dialogue by hosting workshops on Grasshopper and Rhino, while encouraging others to speak on their respective areas of expertise.

Taking initiative to launch the ARE Success Teams Program came with a host of responsibilities for Kevin, including, but not limited to: managing the growing network of members, coordinating schedules and locations for meetings, and distributing study resources, in addition to promoting awareness of the program as a tangible benefit of AIA Nebraska membership. One of the greatest hurdles to studying for the ARE is the limited availability of study resources and the financial burden of acquiring materials. Kevin worked to ensure each Team would have access to hard-copy study materials, as recommended by NCARB and purchased by AIA Nebraska. However, he felt it was important for each member of the ARE Success Teams Program to have a free resource, unique to the program, in addition to the books provided. So, Kevin took it upon himself to develop the ARE Quick Guides, shorthand study guides for each exam division, intended to provide an overview of major study topics. Shown above are just two excerpts from the Project Management study guide and the Practice Management study guide. The length of each study guide depends on the exam, but typically ranges between seven to twelve pages of both written and graphical content. Kevin accomplishes this by studying ahead and compiling notes from primary resources listed in the NCARB ARE 5.0 Handbook.

Mentorship has been a major focus for Kevin since graduating in 2018. He is a firm believer that students from all backgrounds deserve access to learning opportunities to discover and pursue their respective career paths. Shortly after joining CWP Architects, Kevin found out about the ACE Mentor Program and felt that this would be a great way to contribute to his community by providing a learning opportunity to high school students. He has mentored at Omaha North High School and Benson High School over the past three years. The Omaha ACE Program is unique in the fact that mentorship is built into the school's curriculum. This means during the school year, Kevin is in class once a week helping high school students develop a semester-long or year-long project while leaning on his experience to give students insight into the architecture, construction, and engineering industries. Along with in-class mentoring, Kevin also hosts ACE student interns as part of the ACE High School Mentorship & Experience Program. Through this four week program, students spend each week at a different office to gain exposure to a diverse range of work experience. Firms typically participate for one week with two students on a twenty hour schedule before the students switch to a different office the following week. To aid with the growing number of students joining the program, this year Kevin volunteered to host four students, seen above, for two weeks at CWP Architects so that no one would be left out of the program.




